A word from the President



1989-2019: 30 years of service to grandparents

2004-2019: 15 years as a national advocacy and support organization for grandparents and their grandchildren

I am very pleased to celebrate with you a double anniversary, the **30th anniversary** of the founding of the Grandparents Association and the **15th anniversary** of its re-foundation as a national organization covering and serving grandparents throughout Quebec. The Grandparents Association was founded in 1989 and incorporated in 1990 as a local organization in Beauport and the surrounding area. In 2004, it extended its scope of action to all of Quebec. As a result, it has changed its name. In addition, it organizes events and activities in the main urban areas of Quebec. Since 2004, it has maintained a toll-free crisis line for all grandparents and seniors. In Appendices 1, 2 and 3, you will see the regional representativeness of the AGPQ in the 17 administrative regions of Quebec.

The AGPQ held activities, conferences, coffee meetings and information meetings in the following cities: Beaupré, Québec City, Montréal, Longueuil, Boucherville, Sherbrooke, Trois-Rivières, Gatineau, Saguenay, Saint-Félicien, Laval, Val-d'Or, Montmagny, Saint-Damase (Montérégie), Drummondville, Saint-Hyacinthe, Sainte-Geneviève-de-Batiscan, Chambly, Carignan, St-Jean-sur-Richelieu and Rivière-du-Loup.

Highlights of 2018-2019

Family Law Reform

In April 2018, the Chambre des notaires du Québec initiated the Citizens' Commission on Family Law. The purpose of the campaign was to put pressure on political parties to commit to updating family law. The President of the Chambre des notaires has asked our President, Mr. Henri Lafrance, to be one of the seven commissioners to sit on this Commission. It was co-chaired by Alain Roy and Jean-Paul Dutrisac. The commissioners were Me Marie-Ève Brown, Me Sophie Gagnon, Me Sylvie Schirm, and Me Michèle Vatz Laaroussi

Me Luc Trudeau, member of the AGPQ Board of Directors, defended the cause of grandparents and their grandchildren before this commission. This document is available on the [Commission citoyenne n° 1 sur le droit de la famille](#). We invite you to read the summary of what was said about the relationship between grandchildren and grandparents (see Appendix 4).

The Association prepared a brief to the Citizens' Commission on Family Law initiated by the Chambre des notaires du Québec. It was tabled by Ms. Monic Avoine, Vice-President of the Association at the hearings held on June 12, 2018 in Quebec City. It is important that the rights of grandchildren to maintain relationships with their grandparents continue to be maintained through article 611 C.C.Q. We made the Commission aware of the importance of grandparents, which is what was done in our brief and what Ms. Oats defended when she appeared before the Commission.

We have also made recommendations to remind Commissioners that plenary adoptions should not be unduly made. These, as we know, permanently sever the child's filiation ties with his or her family of origin and grandparents.

Volunteers

We continued to focus on intensified collaboration with the Volunteer Centres, particularly with the Centre d'action bénévole de Québec, Accès Bénévolat, (East of Montréal) Centre d'action bénévole de l'Ouest-de-l'île and with the Centre d'action bénévole de Montréal. This collaboration helps us in our recruitment of volunteers.

The AGPQ thus seeks to better manage its volunteers, but above all to recruit new ones. We focus on baby boomers and students in social work and law, as well as our members.

We would like to thank Ms. Monic Avoine, volunteer manager of the helpline, Ms. Céline Pichette, volunteer facilitator of the Facebook Page and Ms. Luc Trudeau for her valuable advice and lectures, which are always much appreciated.

Annual General Meeting

On June 3, 2018, the AGPQ General Assembly was held at Hôtel le Mortagne in Boucherville. More than 40 people attended.

Our visibility has increased significantly over the past year. Currently, there are nearly 1400 people following the page. We invite those of you to love and follow our Facebook page.

Ongoing political issues

The AGPQ will defend the right of grandchildren to maintain a relationship with their grandparents with the Minister of Justice, Sonia Lebel.

We invite each of you to register for the public consultation on family law reform that is currently taking place in various regions because the general public can appear before the Commission and present their arguments on various topics that affect family law in some way.

The Association will follow very closely the work of the Special Commission on the Protection of Youth.

The AGPQ helped a grandmother who was forced to leave her job to take care of her grandchildren. The judge had granted her custody of her grandchildren as a local foster family. But, unlike other foster families, being the grandmother, she had to wait at least 6 months before receiving the financial compensation provided for foster families. The AGPQ has denounced this situation to the ministers of health and to several members of Parliament. To date, she has not yet received a positive response to ensure that grandparents in such a situation are treated fairly. This demand will be submitted to the new Special Commission on Youth Protection.

Non-partisan political analysis

The AGPQ conducted research on trends in case law regarding the relationship between grandchildren and grandparents. The documents produced will be used in the presentation of our brief on family law reform and in our various representations to political authorities.

The AGPQ examined Bill C-78: "An Act to amend the Divorce Act, the Family Orders and Agreements Enforcement Assistance Act and the Garnishment, Attachment and Pension Diversion Act and to make consequential amendments to another Act". A synthesis of this project was prepared by legal volunteers.

Intervention with the media

On October 29, 2018, Ms. Monic Avoine met with a journalist from Beauport Express. On

5 November 2018, Ms Monic Avoine met the journalist Ms Isabelle Légaré of the Nouvelliste de Trois-Rivières.

In June 2018, Ms. Monic Avoine met with Ms. Gisèle Gizard, President of the European Grandparents School.

Meeting of Members of Parliament and Ministers

The AGPQ met with MPs and ministers in 2018-2019 to present its demands and explain the Association's role. We also invited them to refer grandparents who would need help or support to the AGPQ.

To make the AGPQ known, a letter of congratulations was sent to each of the MPs or re-elected on December 10, 2018.

In April 2018, Luc Trudeau met with Kathleen Weil, Minister responsible for Relations with English-speaking Quebecers

On May 26, 2018, Mr. Lafrance met with Simon Jolin-Barrette, Member of Parliament responsible for justice in the 2nd Opposition, to discuss family law reform. He also met with Sylvain Lévesque, a candidate from the Coalition avenir Québec.

On July 3, 2018, Mr. Henri Lafrance met with Minister Stéphanie Vallée and Associate Chief Judge Robert Pidgeon to discuss the renewal of the pilot project "Parenting, Conflict and Resolutions" of the Ministry of Justice.

On July 30, 2018, Mr. Lafrance met with the candidates of the Coalition avenir Québec Émilie Foster, Jean-François Simard and François Legault.

On August 5, 2018, Mr. Lafrance and Ms. Avoine met with the Coalition avenir Québec candidate, Émilie Foster.

On September 18, 2018, Mr. Lafrance met with the Member of Parliament for Lafontaine, Mr. Marc Tanguay.

On October 9, 2018, Mr. Lafrance met with the Member of Parliament for Charlevoix-Côte-de-Beaupré, Émilie Foster.

On November 28, 2018, Mr. Lafrance met with the Minister of Justice, Ms. Sonia Lebel in Montreal.

On December 12, 2018, Mr. Lafrance met with the Member of Parliament for Chauveau, Mr. Sylvain Lévesque.

On March 4, 2019, Mr. Lafrance met with the Member of Parliament for Charlevoix-Côte-de-Beaupré, Émilie Foster.

On March 20, 2019, Mr. Lafrance attended a 6 to 8 meeting with the Minister of Justice, Ms. Sonia Lebel, and the Member of Parliament for Montmorency, Mr. Jean-François Simard.

Crisis line

The crisis line is still widely used by grandparents and still represents the "gateway" to the Association for many grandparents experiencing difficulties. The availability of the crisis line is always 8 hours a day, from 9 a.m. to 5 p.m. Monday to Friday, for a total of more than 2000 hours per year.

Once again this year, we would like to acknowledge the exceptional contribution of our warmest speakers, Ms. Monic Avoine and Ms. Monic Godin. It should be noted that grandparents' calls come from all regions of Quebec. The number of calls was about 1000 this year.

Here are some of the situations encountered by listeners:

1. Parents demand money or property to leave grandchildren to grandparents.
- 2 Parents threaten grandparents: "If you refuse to babysit on weekends, you will never see them again.
- 3 Children are neglected by parents. Grandparents compensate for this by taking care of and caring for the young people. Grandparents keep their grandchildren full-time with the consent of the parents. They pay for all the children's needs. But if they ask to receive social or tax programs related to children (Child Support Payment (Quebec) and Canada Child Allowance), parents threaten them with never seeing the children again.

Children are neglected by parents. Grandparents compensate for this by taking care of and caring for the young people. They get exhausted and ask the CLSC for help. The latter's workers request the intervention of the Director of Youth Protection. The latter places the child in a foster family. If the child is young or very young, he or she will probably be placed with a family that wants to adopt him or her. If this were to happen, grandparents would become foreigners within the meaning of the law.

- 5 Grandparents help their son or daughter who is going through a difficult divorce or separation. When one parent is demonized by the other and suffers parental alienation, it is not only the parent who is targeted, but also his or her parents and siblings. The big losers are of course the children.

6 The son or daughter of the grandparents, father or mother of the grandchildren has died.

The surviving parent wishes to remove the lineage of the deceased parent from his or her life and that of his or her child. He wants to have his child adopted by a new spouse. If this were to happen, grandparents would become foreigners within the meaning of the law.

7) Following any dispute between parents and grandparents, they are denied access to grandchildren. Yet parents were previously very happy with their dedication to child care.

Information meetings

The AGPQ continues to keep its grandparents well informed by holding regular legal information meetings with Luc Trudeau, a lawyer for 35 years in family and youth law. Mr. Trudeau has been a lecturer since 2006 on the law of grandparents and their grandchildren.

The meetings were presented this year in Quebec City, Saint-Hyacinthe, Drummondville, Longueuil, Boucherville and Montreal respectively.

During the information sessions, Mr. Trudeau informs grandparents about the right of grandchildren to maintain relationships with them. It also discusses the psychological aspects and political issues surrounding the exercise of rights.

It was noted that information sessions are increasingly popular and appreciated by members. There are between 35 and 40 people attending each meeting. This increase encourages us to continue and increase the number of meetings. They are also intended to greatly strengthen our members' sense of belonging and the organization's community life.



During the information meetings, Mr. Henri Lafrance, Director (or other members of the Board of Directors) also presents the Association and its main political and social demands. Supporting members are encouraged to raise awareness and denounce to elected officials the unfair or problematic situations experienced by grandparents. This year, the AGPQ organized 15 information meetings.

Sometimes, groups of seniors, families or women invite us to meet their members to explain the difficulties experienced by grandparents. This year, we responded to the requests of four seniors' groups: Québec City, Saint-Léonard (Montréal), Rivière-des-Prairies (Montréal), Maison des grand- parents (Sherbrooke) and the Association des retraités de l'Enseignement (Saint- Hyacinthe).

APPENDIX 4 - Excerpt from the Report of the Citizens' Commission

D- Extended family, relatives and others...

"It takes a whole village to raise a child. "This proverb is nowadays blatantly true. The child now evolves within family environments around which different actors gravitate or take turns. These actors include the step-parent (1) and grandparents who are regularly called upon to perform parental functions (2). In addition, a child may need to be placed in the care of a third party for an extended period of time. It also happens that this third party takes advantage of his authority and situation to abuse his powers and the child (3).

1. The step-parent, a landmark for the child

As explained by the Fédération des associations de familles monoparentales et recomposées du Québec (FAFMRQ), the phenomenon of reconstituted families is no longer marginal ⁽³⁰⁶⁾. More and more children are living in an environment composed of a parent and a new spouse, and earlier in their lives. The role of the person you are commonly referred to as "step-parent" is not uniform, however. While some step-parents will be reserved in their dealings with the child, others will be fully involved with the child and actively contribute to his or her development.

According to several of the persons and organizations heard by the Commission, the law must preserve the "significant ties" that a child may have with his or her step-parent, particularly after the breakdown of the reconstituted family ⁽³⁰⁷⁾. This is one of the key recommendations of the Advisory Committee on Family Law ⁽³⁰⁸⁾. However, the importance of properly defining the concept is stressed. The length of the relationship, the child's age and the nature of the relationship with the other parent are all criteria that may be relevant here ⁽³⁰⁹⁾.

That being said, the Association des jeunes notaires du Québec opposes the recommendation of the Advisory Committee on Family Law to establish a presumption in favour of maintaining the significant relationship. In his view, the onus should be on the step-parent to prove that maintaining the relationship is in the best interests of the child, not on the parent (his or her ex-spouse) to prove otherwise ⁽³¹⁰⁾. This opinion is shared by the FAFMRQ and the Regroupement des maisons pour femmes victimes de violence conjugale, which are concerned about the challenges that maintaining the child's relationships with the step-parent could pose in the context of domestic violence ⁽³¹¹⁾.

Apart from the child's relationship with his or her step-parent, some would argue that the child's relationship with his or her stepsiblings should also be given special attention⁽³¹²⁾. The maintenance of such relationships after the breakdown of the stepfamily would also be likely to promote the child's development⁽³¹³⁾.

2. Grandparents, always more present

The importance of grandparents in the child's life is no longer in doubt today. The opposite is also true. Several individuals and organizations have told the Commission about the distress and distress experienced by some grandparents who are deprived of contact with their grandchildren as a result of the death of their child (who is the parent) or their marital separation. Sometimes the former spouse tries to limit or even block the child's contact with them. Such conduct, says Luc Trudeau, a lawyer specializing in the field, is entirely contrary to the principle of section 611 of the Civil Code, which presumes the child's interest in maintaining personal relations with his or her grandparents.

Me Trudeau, like the representatives of the Association des grand-parents du Québec (AGPQ)⁽³¹⁴⁾, also considers that the term "grandparents" in article 611 of the Civil Code is too narrow in that it does not allow for the inclusion of great-grandparents, as is the case in France⁽³¹⁵⁾. Nowadays, they can also play a key role in helping children.

The AGPQ also made the Commission aware of the dramatic consequences that intra-family adoption has on grandparents. To illustrate its point, the organization reports the story of a grandmother who lost all contact with her granddaughter following the death of her own daughter⁽³¹⁶⁾. After restarting his life with another woman, the child's father exercised his right under the Civil Code to consent to the adoption of the child in favour of his or her new spouse, which led to the breakdown of the original maternal parent-child relationship and thus transformed the maternal grandmother into a complete stranger from a legal point of view⁽³¹⁷⁾.

As explained by the AGPQ and Me Luc Trudeau, grandparents have no control over adoption procedures - which are not systematically notified to them - despite the resulting consequences on their relationship with their grandchildren⁽³¹⁸⁾. According to the lawyer, article 611 of the Civil Code should be amended so that the presumption set out therein is maintained with respect to the original grandparents, despite the loss of their status as a result of the adoption⁽³¹⁹⁾.

The Commission's attention was also drawn to the importance of maintaining the child's relationships with his or her ancestors for many immigrant families, given the predominant place given to the extended family in their culture. Advocating for greater recognition of the realities experienced by transnational immigrant families⁽³²⁰⁾, Rencontre interculturelle des familles de l'Estrie (RIFE) advocates the importance of extending reflection beyond borders.

RIFE argues that it is necessary to ensure that the child's ties with his or her grandparents or other relatives in the ascending line are preserved, even if they have remained in the country of origin⁽³²¹⁾.
